In pursuance of Ministry of Finance, Department of Revenue, Central Board of Excise & Customs's letter F. No. A-12034/SSC/1/2009-Ad-III(B) dated 16.06.2009 and on successful completion of the Physical Endurance Test, the following candidates nominated by the Staff Selection Commission are hereby offered appointment to officiate as Inspector (Preventive Officer) until further orders, in the pay scale of Rs. 9300-34800/- and with usual allowances that are admissible to Central Government Employees from time to time.

2. The conditions of appointment are enumerated in the Annexure. If they accept the offer of appointment on the basis of the stipulated conditions, they should report for joining the post of Inspector (Preventive Officer) **on or before 31.08.2009** before **the Additional Commissioner (P&V), Custom House, Willingdon Island, Cochin – 9**. If the candidate fails to report for duty within the prescribed time, it will be presumed that he / she is not interested in accepting this offer of appointment and the offer of appointment will be cancelled without further notice.

3. The above individuals will be considered to have joined service from the date on which they actually join duty. They are liable to be transferred anywhere in India.

4. No traveling allowance will be allowed for joining on appointment.

5. At the time of joining they should bring the following documents in original.

- Documentary evidence in support of Date of Birth.
- Documentary evidence in support of Educational Qualification.
- Caste Certificate in case of SC/ST/**OBC (only in the prescribed form)**.
- Discharge Certificate and certificate of good conduct from the employer in case the candidate is employed in any of the Offices under the State / Central government / Public Undertaking presently. The certificate should be obtained with reference to this Officer of Appointment.

6. The candidate will be on probation for a period of 2 years from the date on which he / she reports for duty. **The appointment is provisional and is**

subject to the Caste / Tribe / OBC Certificates being verified through proper channel. If the verification reveals that the claim of belonging to SC / ST / OBC or in the case of OBC, the claim of not belonging to 'Creamy Layer' as the case may be, is false, his service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate (applicable in respect of SC / ST/ OBC candidates).

7. The Seniority in the grade will be determined according to the orders in force and communicated later.

The Terms of appointment are as under :
